## Riverside West Elementary School Title One I School, Parent/Guardian, and Family Engagement Policy 2023-2024

Riverside East Elementary School agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the engagement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.

Riverside East Elementary School, in compliance with consistent with section 1118 of the Elementary and Secondary Education Act (ESEA), will take the following actions to encourage parent engagement:

Provide parents/guardians with an annual evaluation of the content and
effectiveness of this policy, the School/Parent-Guardian/Student Compact, and the
PA Future Ready Comprehensive School Level Plan and make recommendations for
improvement. The parents/guardians will meet annually to offer input about the
Title I program and these documents. Parent-Teacher Group meetings and Title
One Committee meetings are held during flexible hours in order to accommodate
work schedules.

- Invite parents/guardians in the joint development of Title One documents and the
  use of Title One funds in planning activities, offering suggestions, and asking
  questions regarding policies and programs. Funds may be used for reasonable or
  necessary expenses for engagement, such as transportation, childcare, or home
  visits.
- Attendance will be taken at most events to collect data. This data will be used to monitor parental engagement.
- Ensure that communication between the home and the school is on-going, two-way, and meaningful by providing Title I information through:
  - Informative Back-to-School Night where, curriculum, standards, and assessments are explained.
  - Orientation for students and parents prior to the first day of school, so students and their parents can meet their teachers and pick-up materials
  - One such example is through the opportunity to tour the school to increase school preparedness. Another example is through the district meeting at the District Office with local day care staff (Early Intervention) to provide registration and transition information. Information about the students who were part of the Early Intervention Programs is provided to their new elementary school teachers to provide current academic levels.
  - Conferences per year for report card discussion, explanation of proficiency levels, and student achievement levels
  - Open invitations to all Home & School/Title One meetings
  - o Minutes for all Home & School/Title One meetings upon request
  - Access to teachers' email addresses, voicemail numbers, Google Classrooms, and websites
  - Access to the school's website, which is updated on a regular basis with information about activities, events, and Title One information
  - School-Parent-Student compact available online to each family, outlining shared responsibilities between home and school
  - A Parent Survey
- Promote and support parenting skills for parents in need and address barriers to participating by providing:
  - Assistance with registration and obtaining clearances
  - o Interpreters for conferences and Annual Meeting, when feasible
  - o Intervention Specialists are available during Back-to-School Night to explain programs and offer assistance.
  - Special area teachers available during conference days to offer recommendations for home activities
  - Referrals to support personnel to obtain information about the outside agencies, when needed
  - Translators for non-English speakers
  - Providing parents/guardians with the opportunity to utilize use district counseling services.

- Encourage parents to become volunteers by:
  - Continuing to partner with the Home & School
  - Assisting parents with completing clearances
- Encourage parents to play an integral role in assisting student learning by:
  - Supplying parents with websites that offer school tips for home
  - Explaining ways to help at home during conferences, Title One meetings, and during Back-to-School Night
  - Inviting parents to special events
  - Offering guest readers
- Promote community collaboration to strengthen the school environment by:
  - Inviting parents and community members to events
  - o Inviting parents and community members to Title One meetings
