District Technology Vision

- ▶ To secure and maintain network infrastructure and communications.

1:1 Technology Program:

- ▶ Each 9th, 10th, 11th and 12th grade student will receive a Chromebook to keep during the school year for ACADEMIC purposes ONLY.
Chromebook, Bag, and Charging Cord – all are labeled with student's name.
- ▶ The Student is responsible for being sure the Device is fully charged. This is “Being Prepared for School”.
- ▶ **The Device MUST be turned in on or before the LAST STUDENT DAY of School each Year.**
- ▶ The same Device will be distributed to the student each September over their 4 years at Riverside.



1:1 Technology Program Continued:

- ▶ \$25 is collected per student EACH YEAR to cover Accidental Damage.

Theft is NOT covered. Report ASAP if it is missing so we can help find it!

- ▶ A loaner Laptop or loaner Chromebook will be given to the student if we cannot repair the student's device in less than 5-10 minutes . We do not want a loss of instructional time during the school day because of a technology issue.
- ▶ **Excessive repairs – Is it a bad device, or lack of care by the student?**
- ▶ At Home -- Filtered and logged
- ▶ At School -- Filtered and logged
- ▶ But we still need your Parental support at home!

Riverside 1:1 Technology Loan Agreement

The link below is a **SAMPLE** of Riverside School District 1:1 Technology Loan Agreement that will go out to all 9th grade students during the 1st week of school. Please be sure both the Parent and Student **READS** and **SIGNS** the agreement were designated. **ONLY the signed papers (3 sheets) need to be returned to the Homeroom teacher, including a \$25 Check or Money Order for Accidental Damage Insurance for the year.** Checks should be made out to Riverside School District. Below is an agreement **SAMPLE**. Do not fill out this **SAMPLE**. Your child will be bringing home a Technology Loan Agreement with some information already filled in such as your Child's name, Year of Graduation, Serial Number of the Device assigned to your child, etc... The **SAMPLE** is available to allow you to begin to review the agreement if you missed the Parent 1:1 Technology Meeting.

We need the signed paper work back by Friday of the 1st week of school. 9th grade students will be getting their devices on the first Monday of the new school year. Please contact Mrs. Chisdock, District Technology Coordinator, if you have a concern about this process as soon as possible.
