Finance Committee – Ms. Antoniacci McHugh reported that preliminary budget work has begun. She also explained Motion #20 (Act 1). She reported that graduation will be on June 10, 2024 at PNC Field in Moosic.

Superintendent's Report – Mr. Brennan congratulated all new board members, Attorney Rinaldi, and Act 93 members. The Vikings Elves distribution will be held on December 14, 2023 at West. The Viking Elves are helping 300 students this year.
